Municipal Election - October 2010

Municipal elections are being held across Ontario on October 25th, 2010. This bulletin is intended to help you understand the process, and to encourage you to participate.

Who Can Vote?

If you are a Canadian citizen, and you own property in Ontario, you can vote in these elections.

Whether you are a permanent resident of South Frontenac Township, or merely own property here, and live elsewhere, you have the right to vote.

That means that you (and your spouse) can vote twice - both 'at home' and at the cottage.

During the second week of October, the municipality will be sending out voters' packages to everyone who is listed on the voters list.

How and When Can You Vote?

All voting in our township will be done by phone or by email. This method has been adopted partly to accommodate landowners (typically cottagers) whose permanent homes are outside the township – you don't need to come all the way here to a polling station.

Eligibility to Vote

The specific eligibility criteria from the Ontario government website are:

A person is entitled to be an elector at an election held in a local municipality, if on voting day he or she is:

- a Canadian citizen;
- at least 18 years old;
- residing in the local municipality or an owner or tenant of land there, or the spouse of such owner or tenant; and
- not otherwise prohibited from voting.

In your voters package will be the phone number and email address as well as your personal PIN identification. Voting will take place for 8 days, up to October 25th at 8pm.

FIMLA 2010 AGM

The Annual General Meeting of FIMLA took place on August 1st, 2010, hosted at 1022 Little Deer Lane. Over 50 members attended.

FIMLA President, Gord Rodgers, welcomed everybody, including Ron Vanderwal, Councillor for Loughborough, and FIMLA member, John McDougall, who is standing as a candidate for Portland District Councillor in the upcoming Township elections.

To celebrate completion of

the Lake Stewardship Plan, a short business meeting was followed by a social event. Gord thanked Elaine Aronson and Cynthia Cole for hosting the meeting and the celebration to follow.

Secretary's Report

Elaine St John, Secretary, reviewed the August 2nd, 2009 minutes, which were unanimously approved as a correct record.

Treasurer's Report

Rod Harris-Lowe, Treasurer, reported that the Association had

51 paid up members at the end of July, 2010. From an initial balance of \$8,446.47 on August 3rd, 2009, he reported expenditure over the year of \$4,907.14. Income from revenues and grants of \$3,183.98, resulted in a balance of \$6,723.31 on August 1st, 2010.

2010-11 Budget

A Budget was submitted proposing expenditure of \$5,000 on Lake Stewardship Plan actions. With anticipated revenue of \$2,800 in the upcoming year, net assets of \$4,500 were forecast for July 2011.

A motion for acceptance of the financial report and budget proposals was seconded and carried, all in favour.

Election of Officers

In the absence of any other nominations by the July 19th deadline, all executive members, except for Rod Harris-Lowe, Treasurer, indicated they were willing to stand for another two years. Elaine St John agreed to double up the role of Treasurer and Secretary.

Gord thanked Rod for his diligence in the last five years at managing the funds, and for all his work on behalf of FIMLA.

A vote was held by a show of hands and the executive were duly elected for another 2 year term as follows:





Fishery Update

Work to improve walleye spawning in Fourteen Island Lake, was planned for mid August. Peter Peart had obtained approval from

MNR (along with funding support) and Quinte Conservation to rehabilitate an old spawning area in the creek that runs from Cranberry Lake into Fourteen Island Lake. Mrs Isabel McLeod, on whose property the creek runs, was thanked for permitting MNR and volunteers to proceed with the placement of rock in this spawning bed.

Water Level of Lakes

In response to concern raised about the water level of the lakes, it was pointed out that one action point in the Lake Stewardship Plan is to get further input from the 'experts', so that the Lake Association can make an informed decision on this matter.

Trousdale Boat Launch

Gratitude was expressed for the Trousdales' co-operation on allowing twice yearly access to the boat launch on Fourteen Island Lake. Further discussions with the Trousdales will occur to see what plans for improving the boat launch might be appropriate this autumn

Meeting Closed at 2:30

Cranberry Rocks

Over a hot, humid week in mid-August, Lake Steward, Peter Peart, and his team of volunteers assisted by three MNR students, completed the restoration of an old pickerel spawning ground that thrived years ago in the stream connecting Cranberry Lake to Fourteen Island Lake.

With the full cooperation of Isabel McLeod whose land this stream flows through, and advice/permission of both MNR and Quinte Conservation, the 12" culvert that allows the stream to pass under her road was replaced and upgraded with one 48" in diameter.

Then the real back-breaking work started - transporting and placing eighteen tonnes of river rock on to the stream bed from this culvert to the exit point into the lake.

After many years, it is hoped that next spring the pickerel will have access to the stream and find protective rocks behind which they'll deposit their eggs, and that the resulting fry will find refuge as they grow.
