n our last newsletter a detailed article outlined the condition of Fourteen Island Lake dam. It was reported that it will take approximately twenty thousand dollars to undertake the required repairs.

A request for funding support for this project has been sent out to the five major partners we have been working with on both the development our Lake Stewardship Plan and implementation of it's recommendations.

We have requested a financial contribution of five thousand dollars from each agency which will be matched with five thousand dollars from our Lake Association.

To date we have not received any responses. There have been significant budget reductions in many Provincial and Federal environmental support agencies so potential funding is tight.

Reports from winter, spring and early summer fishing are good. Once again the spectrum of walleye sizes and weights are being recorded. Once again bass, both small mouth and large mouth, seem to be very plentiful. And

once again young Jack Storms is landing large ones from all three of these categories.

The deer are plentiful, as are the raccoons. And the woods on our island ring with bird songs all day, and thanks to the

whippoorwill, all night sometimes too.

Two areas of concern, however, are the pockets of thick, lime green algae growth, which appeared very early this season. Too early? And secondly for the third consecutive summer we seem to have no baby loons. This worries me and should possibly be a subject for research.

Dam funding (cont'd)

Follow-up calls and hopefully some meetings and presentations will be undertaken in July to get some indication of the support we an expect from these agencies. An update on progress will be made at our August AGM.

The dam is not in immediate danger of failure but undertaking these needed repairs in the near future would ensure the security of our lake environment for decades.

Funding for Fourteen Island Lake Dam Repairs

If we are unsuccessful in securing required matched funding support alternative proposals for financing repairs to the dam will be discussed at the AGM on August 5th.

One proposal is for those living on Fourteen and Mink Lakes to pay a special levy next year, on top of the usual membership fee. The levy could be anything from \$50 to \$100 depending on the level of funding received.

The timing of repairs will depend on how soon we can raise the money needed.

Motion to be tabled (as required)

FIMLA members present agree:

That in the event that the association does not acquire all of the additional fifteen thousand dollars required to fund repairs to the Fourteen Island Dam;

- Then all property owners on Fourteen Island and Mink Lakes shall be requested to pay a onetime special levy for dam repairs;
- That the levy shall be determined according to the amount of partnership support received, with property holders being requested to pay an equal share of the outstanding balance required up to a maximum amount of one hundred dollars.

Turtle Alert


Countless turtles are killed every year on Ontario's roads, including our back lanes. Seven of our eight native turtle species are threatened. Those most often killed are females travelling to nesting areas, which is particularly devastating to turtle populations. You can save a turtle's life by stopping and helping the turtle across the road. Just remember to move them to the side of the road in which they were headed. If you try to turn them around they'll just climb back onto the road again. So, please do your part and keep a lookout when driving, especially during the next few weeks.
